### CHANGE OF NAME : ASPIRE FINANCIAL SERVICES (PTY) LTD TO BETTERCREDIT (PTY) LTD

1. In terms of section 44(1)(b) of the Companies Act, 1973 (Act No. 61 of 1973), **ASPIRE FINANCIAL SERVICES (PTY) LTD (Registration No. 2004/019454/07)**, has changed its name to **BETTERCREDIT (PTY) LTD (Registration Number 2004/019454/07)**, with effect from 13 July 2010.

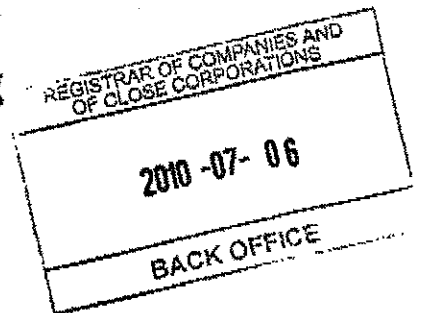

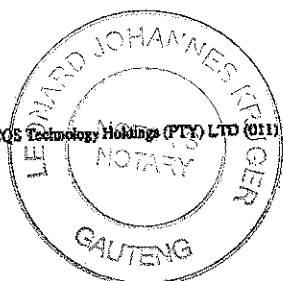
