### CHANGE OF NAME CONCERNING EXXARO TSA SANDS (PTY) LTD TO TRONOX MINERAL SANDS (PTY) LTD

1. **EXXARO TSA SANDS (PTY) LTD (Registration Number 1998/001039/07)** has changed its name in terms of the provisions of the Companies Act, 2008 (Act No. 71 of 2008), to **TRONOX MINERAL SANDS (PTY) LTD (Registration Number 1998/001039/07)**, with effect from 20 July 2012.

The enclosed documentation of this change of name must be filed under **BC No. 5 of 2013** in all deeds registries.

2. Due to the number of deeds that have to be endorsed regarding the change of name, permission is hereby granted to endorse deeds as and when they are lodged for an act of registration.
3. Powers of attorney, consents, and applications signed, and deeds registered after the **date of this circular** must reflect the new name, whilst those signed prior to this date must be accepted unaltered.
4. When relevant bonds are lodged for cancellation, it will not be necessary to endorse them in this regard, provided that the consent to cancellation refers to the new situation.
5. All deeds registries will be supplied with rubber-stamp.
